CCL *	Print or Project words & music
CLA	Photocopy non-music publications
MRL *+	Photocopy typeset sheet music, or share it digitally (email PDFs)
CSL +	Streaming/Posting recordings online of worship services, can show lyrics
CSL-P +	Streaming Plus (as above, and includes Master Recordings & Multi-tracks)
CVL *	Video Licence – show film scenes during worship services
PRS	Live music performances outside of worship services (covers venue)
PPL *+	Play music recordings outside of worship services (covers congregation)

* These licences are offered as an annual OR one-time event licence.

+ These licences are add-on licences to the CCL or PRS licence.

Note on leveraging licence fees in the Diocese:

As of June 2021, within our Diocese there are 27 CCLI CCL accounts and 6 CSL (streaming) licences, among the others listed above. If annual licence payment is centralised (and charged back to congregations), all can receive a 15% discount on each CCL licence. If a number of charges also need a CSL or CSL-P licence, there may be a similar discount on that licence as well. Reporting would still be done individually by charges.

Important to note:
In addition to the PPL Church Licence, your venue must also be covered by a [PRS for Music licence](#) in order to play music recordings (CDs, MP3s etc).

WEDDINGS & FUNERALS

Only the CCL licence is required if **NOT RECORDING** or **STREAMING** the service, as it is considered an 'act of worship'.

If the service is also **STREAMED** but **DOES NOT INCLUDE PRE-RECORDED MUSIC** a CSL licence is required.

If the service is being **STREAMED** and **DOES INCLUDE PRE-RECORDED MUSIC**:

- The CCL Streaming Plus licence (CSL-P) is required if the tracks are authorised under the Streaming Plus licence. These authorised lists are here <https://uk.ccli.com/copyright-licences/authorised-lists/>
- Or permission must be sought from the copyright owners.
- Or the recording must be muted in the stream.

If the service is **RECORDED**, whether by a family member or a professional videographer, ANY live music performances or commercial music recordings captured (or dubbed in afterwards in post-production) will require permission. The Limited Manufacture Licence (LML) from PRS for Music is the best way to obtain this. Visit prsformusic.com/LM for details.
